■ REISCHAUER INSTITUTE GRADUATE WINTERSESSION GRANTS

Supports Harvard graduate students in the humanities or social sciences whose work focuses on Japan and who have already done preliminary research on their topic. *Preference will be given to GSAS students in Japanese studies. Applicants should explain why wintersession research is preferable to summer research.* Applicants should have three years of Japanese language study or have comparable proficiency in the language. Wintersession research grants are intended to cover travel *from Harvard to Japan and return.* *Please note:* Students receiving a wintersession grant may be less likely to receive RIJS summer funding. Research minimum is two weeks (Grants up to \$3,000). **Deadline: OCTOBER 12, 2018 (FRIDAY)**

■ RIJS POSTDOCTORAL FELLOWSHIPS in JAPANESE STUDIES for 2019-20

The Edwin O. Reischauer Institute of Japanese Studies (RIJS) at Harvard University will offer several Postdoctoral Fellowships in Japanese Studies to recent Ph.D. graduates of exceptional promise, to provide the opportunity for postdoctoral fellows to turn their dissertations into publishable manuscripts. Postdoctoral fellows are expected to reside in the Cambridge area during the appointment term and participate in RIJS activities and events. Postdoctoral fellows will also be expected to give a presentation at the RIJS Japan Forum lecture series. Applicants must have received their Ph.D. in 2014 or later, in Japanese studies, in any area of the humanities or social sciences. RIJS especially encourages applications from those who have not previously held postdoctoral appointments at Harvard. Those who are selected to receive fellowships *must have a Registrar-certified Ph.D. degree by June 30, 2019.* **DEADLINE: January 4, 2019 (FRIDAY) Appointment:** 10 months, beginning in September 2019 **Grant Amount:** \$60,000 stipend (10 months); health insurance coverage for grantee; up to \$5,000 in research funds. ■ RIJS JAPAN DIGITAL FELLOWSHIP/POSTDOCTORAL FELLOWSHIP for 2019-20

The Edwin O. Reischauer Institute of Japan Studies (RIJS) at Harvard University invites applications for a Digital Fellow/Postdoctoral Fellow position in Japanese Studies. This position is intended for individuals working in the field of Japanese studies with an interest and commitment to the promotion of digital methods of inquiry, research, publication, and preservation, particularly within the humanities and social sciences. A strong working knowledge of both Japanese and English languages is required. A Ph.D. is not required for this position, but applicants who wish to be considered as a Digital Postdoctoral Fellow must have received their Ph.D. in 2014 or later. RIJS especially encourages applications from those who have not previously held postdoctoral appointments at Harvard. Those who are selected to receive a fellowship *must have a Registrar-certified Ph.D. degree by June 30, 2019.* **DEADLINE: January 4, 2019 (FRIDAY) Appointment:** 12 months, beginning in August 2019 **Grant Amount:** Digital Fellow in Japanese Studies (without Ph.D.): \$55,000 stipend (12 months); health insurance coverage for grantee; up to \$5,000 in research funds. Digital Postdoctoral Fellow in Japanese Studies (with Ph.D.): \$72,000 stipend (12 months); health insurance coverage for grantee; up to \$5,000 in research funds. ■ SUPPLEMENTARY DISSERTATION RESEARCH GRANTS for 2019-20

Provides limited support to Harvard doctoral candidates in the dissertation RESEARCH stage in any field of Japanese studies in the humanities or social sciences for longer term research ie: a semester, 6 mos. or more, up to one academic year. *Please note:* Preference will be given to GSAS students in Japanese studies and those conducting their first year of field research in Japan. Grants will range up to \$28,000. Students may receive this grant only once. **Deadline: FEBRUARY 8, 2019 (FRIDAY)**

- **REISCHAUER INSTITUTE SUMMER RESEARCH GRANTS FOR GRADUATE STUDENTS**
Supports Harvard graduate students in the humanities or social sciences whose work is focused on Japan. In addition to doctoral candidates, continuing students in Harvard Masters programs will be considered, as will graduating Harvard Masters students who will enter a Harvard PhD program in the following year. *Please note:* Preference will be given to GSAS students in Japanese studies. Awards are normally for summer research travel *from* Harvard to Japan, and *return*. (Grants up to \$5,000). *Please note:* Students who have already received an RIJS wintersession grant may be less likely to receive RIJS summer funding.
Deadline: FEBRUARY 8, 2019 (FRIDAY)

- **REISCHAUER INSTITUTE SUMMER LANGUAGE STUDY GRANTS FOR GRADUATE STUDENTS**
Supports A.M. and Ph.D. candidates in the humanities or social sciences for language study. Intended study must be directly related to a thesis/doctoral dissertation in Japanese studies, which cannot be conveniently pursued during the academic year. *Please note:* Preference will be given to GSAS students in Japanese studies. This grant is for graduate students who require third-year Japanese or additional Japanese language study, or for graduate students in the field of Japanese Studies who are pursuing a second language. This grant is NOT intended for modern Japanese language study at the 1st and/or 2nd year level. Contact your Dept and GSAS Fellowships to apply for a GSAS Tuition Waiver at HSS instead. (Grants up to \$7,000).
Deadline: FEBRUARY 8, 2019 (FRIDAY)

- **CONFERENCE TRAVEL GRANTS**
For Harvard graduate students in the field of Japanese studies in the humanities or social sciences. Grant support is limited to travel, lodging, and registration fees for attendance at scholarly conferences where you **must present papers or serve as panel discussants**. (Maximum grant: up to \$800). **Application must be made at least one month in advance of the conference.**

- **NOMA-REISCHAUER PRIZES IN JAPANESE STUDIES**
Awarded to Harvard students who write essays on Japan-related topics. Essays must have been written during the current academic year and the essays may be of any length. One (\$1,000) undergraduate prize and one (\$1,500) graduate student prize are awarded annually. **Deadline: JUNE 10, 2019 (MONDAY)**
Submit one digital copy of the essay, including the completed Noma-Reischauer cover sheet found on the RIJS website and a 250-word abstract. Further details on the submission requirements are found on the RIJS website.

- **RI STUDENT ORGANIZATION GRANTS**
Awarded to Harvard student groups to support activities that focus on or include Japan. Grants are offered on an ongoing basis; however, organizations are encouraged to **apply as early as possible** as funds are limited. Groups seeking support must submit the "Common Application for Student Organization Grants" found on the Asia Center or RI websites.
