## REISCHAUER INSTITUTE SUPPLEMENTARY DISSERTATION RESEARCH GRANT

The Edwin O. Reischauer Institute of Japanese Studies (RIJS) will provide limited support to Harvard doctoral candidates from any field of Japanese studies within the humanities or social sciences. Students must have entered the dissertation research stage of their degree and will use the funds to carry out long-term research in Japan (6-months or one year) or extend field research for up to 6 months at the end of a previous 1-year grant. **Preference will be given to GSAS students in Japanese studies and those conducting their first year of field research in Japan.** (Grants up to \$30,000.) Students may receive this grant only once. For those wishing to extend your research stay, please refer to the detailed instructions in the following statement of purpose section. *This grant is intended to be supplemental to other sources of funding. Students applying to the Reischauer Institute for support are required to apply elsewhere as well.* 

Please note that all support related to travel must follow current Harvard University travel guidelines and safety protocols before, during and after travel. ## **APPLICATION PROCESS:**

1. Apply using <u>CARAT</u>, Harvard's web-based application tool, at: <a href="https://carat.fas.harvard.edu/">https://carat.fas.harvard.edu/</a> After logging in with your Harvard credentials, select "Reischauer Institute Supplementary Dissertation Research Grant" to start your application. Please follow the instructions on CARAT, as well as the specific RIJS instructions stated below. This application requires:

- CARAT application form
- Itemized budget sheet (1 page)
- Current résumé/CV (please do **not** exceed 2 pages)
- Current unofficial transcript from <a href="https://my.harvard.edu/">https://my.harvard.edu/</a> (official transcript is fine as well)
- Statement of purpose (2-4 pages)
- Two letters of recommendation (one letter should be from a current faculty/thesis advisor in the Japan field)
- 2. Submit your completed application on CARAT by Friday, February 9, 2024, 5PM EST.
- 3. Announcement of the awards: April/May 2024

## APPLICATION INSTRUCTIONS

- 1. When filling out the online CARAT application, it is essential that you enter your **G Year, Degree, Department, and Nationality**. In addition, please make sure you fill out the **Title and Synopsis of Your Proposal** (even if it says optional). List the title of your research (even if tentative). **Do not leave these fields blank**.
- 2. Create and upload a separate, one-page itemized budget sheet detailing your expenses for the period/project, for which support is requested, and the specific amount requested from the RIJS. For example, enter: \$20,000 for 8 months (Sept 2024 through April 2025) in Kyoto, Japan (include the city/state/country). If doing research in more than one country, your RIJS budget

should include costs only for the JAPAN portion of your trip. Please also include what other funding you have//will be applying for. <u>You must inform the RIJS if you receive any other award for this proposal after you submit this application.</u>

- 3. Upload your **current résumé/CV.** Please do **not** exceed 2 pages.
- 4. Upload your **current transcript** (either unofficial or official is fine). For an unofficial version, please go to <a href="https://my.harvard.edu/">https://my.harvard.edu/</a> to print a copy of your transcript, scan it as a PDF, and then upload.
- 5. Upload your **statement of purpose**. You should not only outline your research, schedule, and research sites, but also **address the intellectual project rational** (i.e. why your research matters) in **2-4 pages**. *Include your expected date (month and year) of Ph.D. degree completion*. Please indicate if you are applying to extend your research abroad and if so, your current primary research location and institutional affiliation. If you wish to apply for additional funding to extend your research, please address the following in your application:
  - Initial research proposal and progress to date. Please be specific indicate length of stay in Japan, institutional affiliation, etc.
  - Rationale for extended research support
  - Current and anticipated sources of funding

<u>NOTE</u>: Research projects that involve living human subjects must be approved by the University's Committee on the use of Human Subjects in Research (CUHS). You are responsible for making sure that you conform to university guidelines. If your project requires approval from CUHS, you will need to secure approval and submit documentation to RI before you can receive an award. For guidance, please see <a href="http://cuhs.harvard.edu/">http://cuhs.harvard.edu/</a> and then consult with your faculty advisor. - 6. Application must be supported by **two letters of recommendation**. Letter from your advisor must indicate the current stage of your dissertation. Letters of recommendation may be uploaded and submitted directly into CARAT by faculty or via a proxy or may be emailed directly to the RIJS Program Coordinator: Catherine Glover, cglover@fas.harvard.edu by the deadline. Make sure to have your recommender denote which specific fellowship you are applying for.
- 7. If you have received previous funding from the Reischauer Institute, state grant name, year, and dollar amount. **Be sure to fill out this field on the budget page on CARAT**.
- 8) Please note, if applying to more than one RIJS graduate funding application, **you must apply** via **separate** CARAT applications.
